DEED OF NOVATION AND VARIATION OF THE FUNDING AGREEMENT FOR LETHBRIDGE PRIMARY SCHOOL

The Parties to this Deed are:

- (1) **THE SECRETARY OF STATE FOR EDUCATION** of Sanctuary Buildings, Great Smith Street, London SW1P 3BT (the "**Secretary of State**");
- (2) **THE BLUE KITE ACADEMY TRUST**, a charitable company incorporated in England and Wales with registered company number 09889819 whose registered address is at Ferndale Primary and Nursery School, Wiltshire Avenue, Swindon, Wiltshire, SN2 1NX and
- (3) **LETHBRIDGE PRIMARY SCHOOL**, a charitable company incorporated in England and Wales with registered company number 07685652 whose registered address is at Lethbridge Primary School, Lethbridge Road, Swindon, Wiltshire, SN1 4BY (the "**Company**"),

together referred to as the "Parties".

INTRODUCTION

- A. Lethbridge Primary School is an academy within the meaning of the Academies Act 2010 (the "academy") and is currently operated by the Company (a single academy trust).
- B. The Secretary of State and the Company entered into a Funding Agreement on 1 August 2011 (the "**Agreement**") for the maintenance and funding of the academy (attached as Schedule 1).
- C. It is proposed that, with effect from 00.01 am on 1 July 2022 ("**Transfer Date**"),
 The Blue Kite Academy Trust will assume responsibility for the management and
 operation of the academy in succession to the Company.
- D. The Parties wish to novate the Agreement to The Blue Kite Academy Trust and the Secretary of State and The Blue Kite Academy Trust wish to vary the terms of the Agreement subject to the provisions of this Deed.

LEGAL AGREEMENT

1. Any word or phrase used in this Deed shall, if that word or phrase is defined in the Agreement, bear the meaning given to it in the Agreement.

NOVATION

- 2. The Company transfers all its rights and obligations under the Agreement to The Blue Kite Academy Trust with effect from the Transfer Date. With effect from the Transfer Date, The Blue Kite Academy Trust shall enjoy all the rights and benefits of the Company under the Agreement and all references to the Company in the Agreement shall be read and construed as references to The Blue Kite Academy Trust.
- 3. The references in the Agreement to the Master Funding Agreement between the Company and the Secretary of State shall be read as a reference to the Master Funding Agreement between the The Blue Kite Academy Trust and the Secretary of State.
- 4. With effect from the Transfer Date, The Blue Kite Academy Trust agrees to perform the Agreement and be bound by its terms in every way as if it were the original party to it in place of the Company.
- 5. With effect from the Transfer Date, The Secretary of State agrees to perform the Agreement and be bound by its terms in every way as if The Blue Kite Academy Trust were the original party to it in place of the Company.

OBLIGATIONS AND LIABILITIES

- 6. With effect from the Transfer Date, the Company and the Secretary of State release each other from all future obligations to the other under the Agreement.
- 7. Each of the Company and the Secretary of State release and discharge the other from all claims and demands under or in connection with the Agreement arising after the Transfer Date.
- 8. Each of The Blue Kite Academy Trust and the Secretary of State will have the right to enforce the Agreement and pursue any claims and demands under the Agreement against the other with respect to matters arising before, on or after the date of this Deed

as though The Blue Kite Academy Trust were the original party to the Agreement instead of the Company.

INDEMNITY

VARIATION

- 11. The Secretary of State and The Blue Kite Academy Trust agree that with effect from the Transfer Date the Agreement shall be amended and restated so as to take effect in the form set out in Schedule 2 to this Deed.
- 12. As varied by this Deed, the Agreement shall remain in full force and effect.
- 13. This Deed shall be governed by and interpreted in accordance with English law.
- 14. The Parties irrevocably agree that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim that arises out of, or in connection with, this deed or its subject matter or formation (including non-contractual disputes or claims).

COUNTERPARTS

15. This Deed may be executed in any number of counterparts and by the parties to it on separate counterparts, each of which when so executed and delivered shall be an original, but all the counterparts shall together constitute one and the same instrument.
