As Headteacher of Ferndale Primary he led them from being judged as Special Measures by the Local Authority to an Ofsted grade of Good with Outstanding features two years later. This resulted in the school being included in the top 100 most improved schools and Leadership and Management being rated Outstanding by Ofsted. Gary also received recognition from MPs regarding his work in raising achievement for Disadvantaged Pupils.

In 2016 Ferndale Primary received an award for highest primary school achievement in Swindon, this followed a national award for Children's Progress, putting the school in the top 10% of the country.

Gary has led school improvement initiatives across Swindon for many years and was recognised for his effective School to School support in 2017 with an award. He has also worked with National Literacy and Numeracy strategies as leading teacher and supported teachers new to year 6 across the London Borough of Redbridge.
